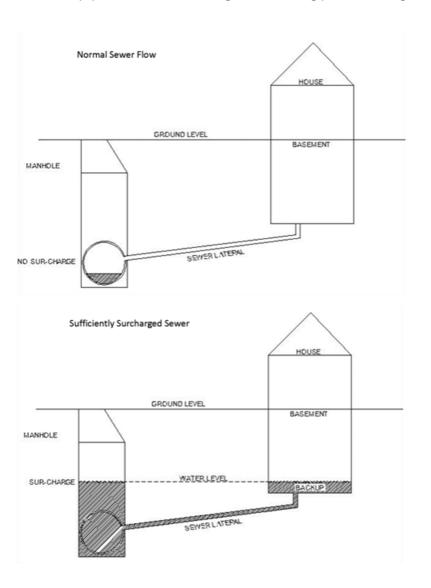

#### **UNDERSTANDING SEWER SURCHARGE – WATER IN BASEMENTS**

Heavy rain – and sometimes melting snow – can result in a situation where there is too much water for the sewer pipes to carry away. The amount of water a sewer pipe can carry can be limited by the size of that pipe. Think of draining a swimming pool with a garden hose versus a fire hose.



When the design capacity of a sewer is exceeded, it is surcharged. Basement areas below the water level may backup.

If your building recently has experienced a back up for the first time, it may be because of unique storm conditions or because of increased inflow and infiltration into the sewer. Infiltration occurs when parts of the system have deteriorated, allowing groundwater to enter the sewer through holes, cracks, joint failures, and faulty connections. Water that enters through connections like gutters and uncapped sewer cleanouts is called inflow. Inflow and infiltration increase the likelihood that there will be too much water and the sewers will surcharge.

Once the rain stops, surcharged sewers are able to drain away excess water. Water that backed up into basements can recede.

The Water Board has great sympathy for property owners who experience basement backups during heavy rain or snowmelt events. Its crews work hard to maintain the sewer system so that it performs as well as possible.

However, the Water Board cannot function as insurer for all users of the sewer system or pay claims for damages that occur when basements back up because the amount of water exceeds the design capacity of the sewer pipes to carry it away. For these reasons, the Water Board strongly urges all building occupants to consider purchasing insurance policies that provide coverage for water backups.

If you experience water in your basement during dry weather, it may indicate a problem with the Water Board's sewer system. Please report the issue to the Water Board at (716) 283-9770 and we will respond as soon as possible; problems with Water Board sewer mains that impact buildings are made a priority for repair.

## Facts and Frequently Asked Questions for Retiree Medical Coverage

The Water Board's contracts with the majority of its retirees provide for medical benefits in retirement. The applicable Collective Bargaining Agreements provide that these benefits will be supplemental to Medicare when a covered individual reaches age 65.

For example, the 2005-2010 CBA provided:

## Section 10.2 - Health Care Program for Retirees

1. Qualification: All employees covered by the terms of this Collective Bargaining
Agreement and who retire and have reached age fifty (50) and who have accumulated a
combination of years worked plus their age so that such combination totals seventy (70)
or greater, shall be entitled to a Health Care Program in accordance with the plan as
provided for in Section 10.1 (Tier I or Tier II coverage) until the individual reaches the
age of sixty-five (65), at which time the Niagara Falls Water Board agrees to provide
group hospitalization and surgical benefits as provided in Section 10.1 supplemental to
Medicare for those who qualify under this Agreement. Additional restrictions for new
hires are identified in 10.2.3.

The 2017-2024 CBA contains the same language:

#### Section 10.2 - Health Care Program for Retirees

1. Qualification: All employees covered by the terms of this Collective Bargaining
Agreement and who retire and have reached age fifty (50) and who have accumulated a
combination of years worked plus their age so that such combination totals seventy (70)
or greater, shall be entitled to a Health Care Program in accordance with the plan as
provided for in Section 10.1 (Tier I or Tier II coverage) until the individual reaches the
age of sixty-five (65), at which time the Niagara Falls Water Board agrees to provide
group hospitalization and surgical benefits as provided in Section 10.1 supplemental to
Medicare for those who qualify under this Agreement. Additional restrictions for new
hires are identified in 10.2.3.

To give effect to these contract provisions, Water Board staff worked closely with Highmark Blue Cross to ensure that the supplemental Medicare plan, Forever Blue Plan 799, provided benefits as close as possible to the medical plan retirees hired prior to January 1, 2008 were enrolled in. Because there is a limited window for enrollment in this type of program, in May 2024 the Water Board sent information about the supplemental Medicare plan to retirees over 65 years in age and is switching these employees to the Forever Blue 799 plan effective July 1.

The Water Board and Highmark hosted several informational meetings for retirees and have answered dozens of phone inquiries in an attempt to help retirees understand the Forever Blue 799 plan and coverage. Many retirees are excited to enroll in the Forever Blue 799 plan which contains some enhancements not available under their current plan. Complete details are available to retirees by calling Director of Administrative Services David San Lorenzo at (716) 283-9770 or Highmark Senior Client Manger Raphael Rodriguez at (716) 912-4466.

Some highlights of the Forever Blue 799 Plan include:

- Covered retirees will continue to pay \$0 for your insurance premium.
- \$0 copays for Medical and Hospital coverage in network.
- \$0 co-pay for in-network inpatient hospital care and all outpatient physician services.
- \$0 first tier preferred generic drugs and \$1 for all other tiered medications.
- \$0 co-pay for your annual physical and over 20 preventive services (i.e., physical, routine colonoscopy and mammogram, flu vaccine etc.)
- \$0, gym membership at all Silver Sneakers participating facilities (over 16,000 nationwide).
- \$0 co-pay for Diabetic supplies, monitors, lancets, test strips, incl. diabetic shoe inserts and compression stockings.
- \$300 Vision allowance you can use toward the cost of eyewear.
- \$300 Dental allowance for dental care.
- \$500 allowance for Acupuncture and Massage benefits.
- \$0 routine chiropractic benefits up to 12 visits a year.
- Hearing Aid benefit (through TruHearing) provides hearing aids at a \$499 or \$799 copayment per aid.

#### **Frequently Asked Questions**

- 1. The first letter I received in the mail indicated that I have Tier 1 Medical benefits but when I retired, I was Tier 3. What does this mean?
  - Tier 1 Medical refers to the level of benefits that you and your spouse are eligible to receive as a retiree. This is a separate tier system and has no relation to the NYSLRS.
- 2. Will my spouse be able to continue to receive health insurance benefits when I transition to the Medicare plan?
  - Yes, the change to the Forever Blue plan will not affect your spouse's eligibility to receive coverage for life. Covered spouses under age 65 will continue to be covered under the PPO 812 plan until age 65.
- 3. I have Dental and Vision coverage through the Water Board already. What happens to that coverage when I am enrolled in the Forever Blue Plan 799?
  - Dental
    - o Current dental coverage (NOVA) remains the same.
    - The Forever Blue plan provides a \$300 allowance for any dental care at any dental provider in addition to your current dental coverage. You can use these dollars to help pay for any copays or coinsurance that you have *after* using your Dental coverage through NOVA. Receiving the reimbursement, which is \$300 per member per year, requires you to complete a reimbursement form and an itemized receipt. Please allow 6-8 weeks for processing.
  - Vision
    - o Current vision coverage (EyeMed) remains the same.
    - The Forever Blue plan also offers a Vision benefit in which you receive a \$300 allowance at Davis Vision providers. You cannot mix the two coverages unfortunately. You can choose to purchase your regular glasses with one benefit and purchase prescription sunglasses with the other if you choose.

# 4. Why do I need to reach out to my doctors and specialists and notify them that my coverage is changing?

Whenever there is an insurance change it is extremely important that you notify your doctors and specialists. This will allow them the time to account for any changes they may need to make on their end whether it be an authorization for a procedure, update prescription requests or medical authorizations which will help ensure claims are processed correctly and that you are able to receive the care you need without interruption.

#### 5. Why is the Niagara Falls Water Board requiring me to switch to this plan?

The NFWB negotiated into prior Collective Bargaining Agreements that retirees over age 65 will receive their health insurance benefits supplemental to Medicare. The Forever Blue 799 plan is a PPO Medicare Supplement plan designed to meet the needs of Water Board retirees and to provide as good as or better coverage than the plans it is replacing. Medicare supplement plans help address the skyrocketing costs of health coverage that affect all employers large and small. The plan offers the flexibility to provide similar benefits to what retirees are currently provided, at a lower cost to the NFWB, while at the same time providing supplemental benefits that retirees enjoy such as \$0 fitness (gym) membership, preventive services, dental/vision benefits etc.

#### 6. Are there other benefits with the Forever Blue plan that I might be interested in?

- Yes! You are urged to review the attached Enrollment book which provides additional information about additional services and or programs you have available to you. Examples include:
  - Annual Rewards program members receive \$20 for receiving their Annual Wellness visit, colorectal screening, and breast cancer screenings
  - Care at Home program \$0 in home care for members
  - Comprehensive Case and Disease Management services
  - Telemedicine services

#### 7. Does the Forever Blue plan cover prescriptions?

Yes, the Forever Blue plan has a 5-tier prescription plan, copays are \$0/\$1/\$1/\$1 which are similar to the copays most of you pay today for your prescriptions. The plan also offers mail order at just 2 co-pays for a 90-day supply. The list of drugs will differ slightly from your current formulary. Please refer to the formulary included in the enrollment kit mailed to retirees over 65 for your reference. Can't find your drug? Please reach out to the Highmark number above for help!

- 8. Will Forever Blue cover me when I leave the area while on vacation or for longer periods during the winter months?
  - You will have access to in-network and out-of-network providers doctors when traveling throughout the nation. The Medicare PPO Network Sharing program provides flexibility while traveling, allowing you to receive the same great care you are used to getting at home, at the same cost. Should you receive services from an out-of-network provider, your copays will be slightly higher. While travelling outside of the U.S. you can receive urgent and emergency care worldwide.
- 9. Can I remain enrolled in the Forever Blue 799 plan if I decide to move permanently outside of Western New York?
  - Yes, the plan will allow you to reside anywhere in the United States.

Mr. Costello thanked the Board for its confidence in him upon his appointment as Executive Director.

He noted with respect to Resolution No. 5 in the packet that for almost a decade the NFWB has been having conversations about the WWTP effluent turbidity and appearance. The WWTP SPDES permit is currently undergoing a full technical review. The current treatment plant cannot meet anticipated new limits and requirements. The proposed Order on Consent offers time to design and implement improvements necessary to water quality, provides interim effluent limitations pending the completion of the necessary work, and greatly will enhance the Board's ability to obtain grant funds, as projects required by Consent Orders receive extra points in the grant scoring process.

Mr. Meyers from CPL updated the Board on the anticipated delivery date for the new chlorine scrubber. Work will begin in July and be complete in August, at least a month ahead of schedule.

#### 3. Operations Executive – David Conti

Mr. Conti noted that a recent inspection by EPA for Safe Drinking Water Act compliance at the WTP went very well. Parts have been ordered to rehabilitate the lighting in the tunnel to the Gorge Pump Station. He is applying to NYSDOH to have planned confined space training count for operator recertification credits.

Chairman Forster asked Mr. Conti to take over the Generator and Main Pump No. 2 projects at the WTP.

#### 4. Outside Infrastructure Updates – David Conti

Mr. Conti observed that the Operations and Maintenance report shows an uptick in bypass pumping. This can be attributed to stormy weather.

#### 5. Engineering – Douglas Williamson

Mr. Williamson explained that the water mains that are part of a planned grant application to be authorized by one of the resolutions in the Board packet were selected based on an analysis of the system to find where there is bottlenecking. All but one of the mains is a 4" main, and will be replaced with larger diameter pipe. This will help increase flow to some of the "red" hydrants in the system that have lower volumes of water available.

Mr. Joyce was off; Mr. Costello reported that IT has been working on further enhancements to security at the Gorge Pumping Station including access cards for elevator use. There is now functional surveillance camera coverage for the 56th Street water tank.

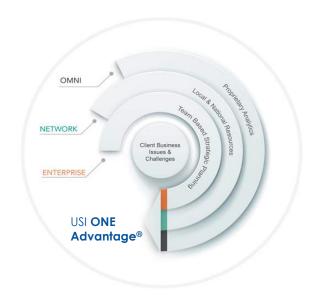

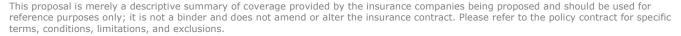

#### AUTHORIZING PROCUREMENT OF ELECTRIC VEHICLE AND DISPOSAL DIESEL SUV

**WHEREAS,** Water Board staff periodically review its fleet status and needs, including seeking to replace costly or maintenance prone vehicles with newer, more efficient vehicles in order to minimize downtime, reduce emissions, and generate cost savings through procurement of less fuel; and

**WHEREAS,** staff recommend disposal of the Water Board's 2021 Chevrolet Tahoe, a diesel-fueled SUV that has been subject to increasing maintenance expenses, and procuring an electric vehicle to replace that vehicle in the Water Board's fleet; and

**WHEREAS**, the Water Board is eligible to claim a \$7,500 Federal tax credit for eligible electric vehicles under the Inflation Reduction Act by following a procedure called elective pay, where the amount of the credit is treated as a payment of tax and then refunded; and

**WHEREAS,** Water Board staff procured quotations for electric vehicles eligible for the tax credit and negotiated to apply the value of the 2021 Chevrolet Tahoe against the purchase price of the electric vehicle; and

WHEREAS, McGuire Chevrolet holds an NYS Office of General Services contract for Class 1-8 Vehicles and provided the Water Board with pricing pursuant to that contract, but the OGS contract does not account for trade-in values and the ultimate price to the Water Board for a 2024 Chevrolet Blazer, from dealer stock at McGuire's Grand Island Dealership, does not meet the threshold whereby procurement via competitive bidding is required; and

**WHEREAS,** McGuire Chevrolet has quoted a price with fees and after discounts of \$49,930.43 for a 2024 Chevrolet Blazer EV and has offered a trade-in value of \$35,500 for the 2021 Chevrolet Tahoe, for a net purchase price of \$14,430.43; and

# State & State

#### What is elective pay?

Elective pay allows applicable entities, including tax-exempt and governmental entities that would otherwise be unable to claim certain credits because they do not owe federal income tax, to benefit from some clean energy tax credits. By choosing this election, the amount of the credit is treated as a payment of tax and any overpayment will result in a refund.

For example, because of the Inflation Reduction Act, a local government that makes a clean energy investment that qualifies for the investment tax credit can file an annual tax return with the IRS to claim elective pay for the full value of the investment tax credit, as long as it meets all of the requirements including a pre-filing registration requirement. As the local government would not owe other federal income tax, the IRS would then make a refund payment in the amount of the credit to the local government.

## Are state and local governments eligible?

Yes. States, political subdivisions and their agencies and instrumentalities are all eligible for elective pay. This includes the District of Columbia. It also includes cities, counties and other political subdivisions. Water districts, school districts, economic development agencies, public universities and hospitals that are agencies and instrumentalities of states or political subdivisions are also included.

# How do I make the elective payment election?

Eligible entities not normally required to file an annual tax return with the IRS should file Form 990-T along with any form required to claim the relevant tax credit.

However, there are steps leading up to this, such as a required pre-filing registration process. An EIN or TIN is required to complete the pre-filing registration process.

Electronic return filing is strongly encouraged.



# What will I need to do to receive a payment?

- **1. Identify and pursue the qualifying project or activity:** You will need to know what applicable credit you intend to earn and use elective pay for.
- Determine your tax year, if not already known: Your tax year will determine the due date for your tax return.
- **3. Placed in service:** The applicable credit property must be placed in service BEFORE a registration number will be issued.
- 4. Complete pre-filing registration with the IRS: This will include providing information about yourself, which applicable credits you intend to earn, and each eligible project/property that will contribute to the applicable credit and other information required. Upon completing this process, the IRS will provide you with a registration number for each applicable credit property. You will need to provide that registration number on your tax return as part of making the elective pay election.
  - Complete pre-filing registration in sufficient time to have a valid registration number at the time you file your tax return.
- Satisfy all eligibility requirements for the tax credit and any applicable bonus credits, if applicable, for a given tax year:
  - You will need the documentation necessary to properly substantiate any underlying tax credit, including if bonus amounts increased the credit.
- File Form 990-T by the due date (or extended due date) and make a valid elective payment election.

**WHEREAS**, the Niagara Falls Water Board ("Water Board") actively is upgrading its information technology ("IT") and physical security infrastructure to protect its critical infrastructure and its personnel; and

WHEREAS, Water Board IT employees have evaluated current physical security hardware and determined that Verkada brand equipment is appropriate to deploy when adding or upgrading physical security assets, as those systems can be installed and maintained without requiring a third-party contractor, are scalable, and have robust information security; and

**WHEREAS,** the Water Board can procure Verkada security hardware and associated licenses through vendor Insight; and

**WHEREAS,** Insight has provided a quotation dated May 20, 2024, No. 0227429560, for physical security equipment totaling \$6,350.23 per NYS Office of General Services Information Technology Umbrella Contract No. PD67645, Group 73600, Award 22876, and pursuant to General Municipal Law § 104, the Water Board is authorized to make purchases from such competitively-awarded OGS contracts; and

**WHEREAS,** Insight has provided a second quotation dated May 20, 2024, No. 0227429576, for 10 years of subscription licenses needed for functionality of the Verkada hardware, for a total cost of \$23,932.41; and

# AMENDMENT NO. 2 to EMPLOYMENT AGREEMENT Between Niagara Falls Water Board and Sean W. Costello

This agreement for an employment contract amendment is made by and between the Niagara Falls Water Board ("Water Board") and Sean W. Costello ("Employee"), with the amendment effective as of June 24, 2024.

WHEREAS, the Water Board and Employee entered into an Employment Agreement for Employee to serve as General Counsel and Secretary with an Effective Date of May 21, 2018 ("the Agreement"); and

WHEREAS, the parties have agreed that Employee shall serve as Water Board Executive Director; and

WHEREAS, the terms of Employee's compensation shall remain unchanged, but as consideration for Employee's service as Executive Director, this amendment No. 2 grants Employee an extension of the Employment Agreement with provisions on renewal of the Agreement and the use of a Water Board vehicle as is consistent with the response, travel, and field responsibilities of the Executive Director; and

NOW THEREFORE, in consideration of the mutual promises and covenants contained in this Amendment, and such other good and valuable consideration the receipt and sufficiency of which the parties hereby acknowledge, the parties agree to amend the Agreement as follows:

#### **1. Nature of Position and Duties** is AMENDED to add:

Employee shall serve at the pleasure of the Board of Directors as Executive Director of the Niagara Falls Water Board. While Employee is Executive Director he shall continue to serve as General Counsel, except the Board may suspend, transfer to another attorney, or otherwise modify this requirement as it deems proper. If the Board ends Employee's service as Executive Director, Employee shall serve as General Counsel for the remaining term of this Agreement and until the Agreement is terminated as provided for in Section 6, Termination. While serving as Executive Director, Employee shall be designated a policymaker for the purpose of NYS Commission on Ethics and Lobbying in Government regulations.

#### **3. Benefits** is AMENDED in part as follows:

Employee shall not be entitled to a company car. Employee shall have a Water Board vehicle to use while serving as Executive Director, as in that role Employee is expected to be available to respond to emergencies, to travel as necessary to further the Water Board's interests, and frequently to visit Water Board facilities and field work locations. This vehicle is to be used for Water Board business and the value of Employee's commuting/de minimis personal use shall be considered taxable as required by applicable IRS Regulations.

- **4. Term** is DELETED and replaced with the following:
- **4. Term.** Per Amendment No. 2 to this Employment Agreement, the term of this Agreement shall be from June 24, 2024 and continuing through December 31, 2026. The Employment Agreement shall automatically renew for three-year terms unless notice is given of non-renewal no later than 90 days prior to the commencement of a new term.

With the exception of the changes made herein and hereby and any other provisions which are null while Employee serves as Executive Director, the Employment Agreement originally Effective as of May 21, 2018 between the Water Board and Employee remains, in all other aspects, in full force and effect.
